### Ph. D. Coursework Guidelines

#### Eligibility criteria for admission to the Ph.D. programme

- Master Degree in Social Work with a minimum of 55% marks.
- The selection procedure shall be based on the marks secured in the entrance examination conducted by Bankura University and followed by a PPT presentation of the research proposal and a personal interview.
- Reservation of seats and other concessions for the SC, ST, O.B.C.-A/B, PH and other special categories of candidates notified by the government shall be enforced from time to time.
- As per Bankura University regulations regarding the doctoral (Ph.D.) degree2017, after admission to the PhD programme, a research student shall need to complete the course work for a minimum period of one semester as prescribed by the respective department. Women candidates may be allowed a relaxation in case of maternity.
- Candidates already holding M.Phil. degree or those who have already completed the course work in any integrated M.Phil. /Ph.D. programme from another university may be exempted from the Ph.D. coursework. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work as prescribed by the Department.
- 75 % attendance for coursework classes shall be mandatory.
- The course work shall be of 12 credit hours per week whereas each course shall comprise of 4 credit hours. This may include lectures, seminars, tutorials, field work, literature review, article and paper presentation, article or book review, research proposal writing, seminar presentation, etc.

#### Eligibility for admission to the examination

- A candidate shall be allowed to register to the Ph.D. degree programme if s/he has undergone the course work as prescribed by Bankura University. Moreover, s/he has to secure no less than 75 percent attendance, successfully complete the Pre-Ph.D. course work and pass the ESE (End Semester Examination).
- In addition, synopsis of the respective Ph.D.thesis has to be approved by the BRS (Board of Research Studies) of the Department.

#### Award of grades

• A Ph.D. student has to obtain a minimum of 55% of marks or its equivalent grade in the UGC7-point scale (or an equivalent grade/CGPA in a point scale wherever grading system is followed) in the course work in order to be eligible to continue in the programme and submit the dissertation/thesis.

• Maximum two chances shall be given to a student for clearing the coursework, failing which may lead to cancellation of admission.
