It is unanimously resolved that -

- 1. All the scholars of Ph. D. Programme 2020-21 have to download the Form and Admit Card in relation to the Ph. D. Course Work Examination 2021-22 and submit it to The Research Coordinatorwithin 28.02.2022 after complying with all the formalities/directives as mentioned on the examination Form and Admit Card which will be finally submitted to the Controller of Examination from the office of the Research Co-ordinator.
- 2. The list of paper setters, moderators and examiners for the Ph. D. Course Work Examination 2021-22, will be sent to The Controller of Examination through the office of the Research Coordinator. The Controller of Examination will issue the appointment letters to the paper setters, moderators and examiners. The above list should be submitted by the Chairpersons of the Doctoral Committee to the office of the Research Co-ordinator by 18th February, 2022.
- 3. The Ph. D. Course Work Examination 2021-22 must be completed on and from 2nd March, 2022 to 4th March, 2022.
- 4. The Paper I will consist Research and Publication Ethics (RPE) of 20 marks and will be incorporated in such a way so that the full marks of Paper I will not exceed 100 marks. The Question Paper on Research and Publication Ethics (RPE) will be provided centrally through Dean, (Officiating), Faculty Council of P.G. Studies in Arts, Science.
- 5. The Ph. D. Course Work Examination 2020-21 will be held in online mode. The question paper of the said examination should be given to the candidates through e-mail, 30 minutes before the commencement of examination and snapshot of the answer sheet should be mailed to the Convenor's mail-id within 30 minutes from the end of the examination. The Chairperson of the respective

Doctoral Committees will distribute those answer sheets among the examiners. Obtained marks of the candidates in their respective papers should be submitted to the Controller of Examination within 8th March, 2022. The Chairperson of the Doctoral Committee will preserve all the documents regarding the course work examination. No external expert should be allotted for moderation and assignment/project representations.

6. The students who are exempted from Ph. D. Course Work will only have to answer on the question of Research and Publication Ethics (RPE) comprises in Paper I under the head "Special Group" which is mandatory for all and one hour time will be allotted for the candidates who will attempt only the Research and Publication Ethics (RPE). Separate certificate will be issued to such candidates also.
