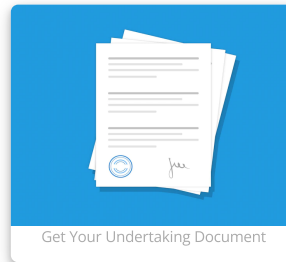
Other organisations/bodies working in this field have also attempted to define ragging, the variety of definitions being reflective of differences in perspective.



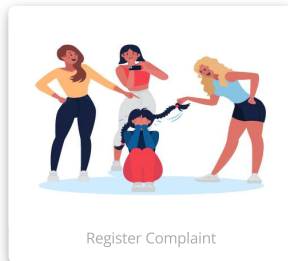

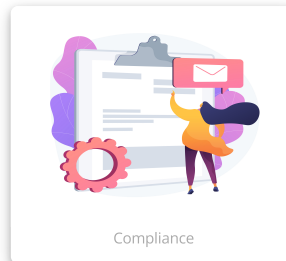
