Concept Note & CFP

Humanistic thinking appears inadequate when it comes engage with contemporary climate catastrophe, damaged ecosystem, mass species extinction, socio-political changes, exceptional growth of technology, AI and prosthesis. These unprecedented crises require a radical re-structuring/re- aligning of our established mode of knowledge production – theoretically, ethically and methodologically. Since 'the human' should be located in its entanglements with the non-human others (environment, animal, technology, objects etc.), posthumanists find it urgent to re-think one fundamental question: What it means to be human?

Humans are no longer the biological agents of this planet. They are another telluric force – a geological agent. This transmutation of human agency (i.e. from biological agent to geological agent) radically destabilises the pillars of modernity and an unwritten 'modern constitution'. Human agency, freedom, ethics, reflexivity (which largely constitute the pillars of modernity), as a result, should be rethought and reconceptualized. With the publication of Bruno Latour's book, *We Have Never Been Modern* in 1991, dualistic mode of thinking and the fence-making practices of an unwritten 'modern constitution' faced a radical challenge; and they were found no longer tenable. Most importantly, a profound incredulity towards Western modernity has swept across academia in the last few decades. We are made to envision and usher in a post-dualistic mode of existence and an ontologically interdependent or entangled existence of the human and the non-human, as Latour might advocate.

Once the very idea of the human is challenged, the rich legacy and edifice of humanist thoughts crafted over the past centuries crumble down. As a result, existing socio- political thoughts no longer remain purely intra-human conflicts and contracts. Non-human elements (such as green elements, geological and nanographic time, microbes, material agencies, technology, AI and many other planetary elements) made their presence inevitable in the existing intra-human drama of existence. Human agency has lost its exclusivity and the non-human others reclaim their 'agentic capacities'.

Since the last decade of this new millennium, there has been a proliferation of book series, monographs, edited volumes, journal articles, symposia, and web-blogs that seek to locate the interfaces of critical and scientific idioms, entanglement of the social and biological, the erasure of disciplinary boundaries and the interventions of the geomorphic and geopolitical in the wake of such unprecedented planetary crises, caused largely by climate change. As the pressure mounts, re-arrangement and re- alignment of the existing theoretical, conceptual and interpretative frameworks stands increasingly necessary and urgent.

The conference-cum-workshop aims to address what Posthumanism is and what consequences it might have for the Humanities and Social Sciences in general. Topics may include (but not solely restricted to):

- Genealogy of the Posthuman: Were We already Posthuman?
- Anti/Trans/Meta/Post-humanism
- Critical Posthumanism
- Philosophical Posthumanism
- Posthuman (Bio)ethics, (Bio)politics and Rights
- Technology, Artificial Intelligence, Prosthesis, Human Enhancements and Robophilosophy
- Posthuman Citizenship and Digital Surveillance
- The Anthropocene, Posthuman Ecology, Speciesism and Animal Ethics
- New Materialisms
- Art, Media and Aesthetics in Posthuman Era
- Material Feminism
