

About Bankura University

Bankura University was established by the West Bengal Act XIX of 2013 and the assent of the Governor was first published in the Kolkata Gazette, Extraordinary, of 6th January, 2014. Bankura University is committed to the dedicated task of disseminating higher learning in this region and it promises to move into a glorious future by promoting the study of indigenous folk and cultural tradition as also by a sustainable rural and tribal development. Bankura, historically known as Mallabhum, can truly boast of a rich heritage of traditional cultural excellence. It is evident in its traditional Dokra art, the intellectual and artistic triumphs of the 18th-century mathematician Subhankar (the well-known Subhankari Arya), the temple town of Bishnupur and the artistic contributions of Jamini Roy and Ramkinkar Bej. This university will sustain and strengthen unique a dissemination of knowledge systems in language, literature, cultural studies, social sciences and multiple branches of the study of science. Now, it comprises of four campuses at Purandarpur, Puabagan, Mithila and Chhandar in Bankura district. Bankura University is recognized under Section 2(f) & 12(B) of the UGC Act, 1956 and also accredited by NAAC. Department of Law has started its journey in 2014 along with other 10 departments of the Bankura University. The department is a part of the School of Social Sciences in this University. At present the department offers two courses, namely, Master of Laws or LL.M. and Ph.D. in Law. From the ... very beginning department has emphasized in doing research on the various fields of Law including various socio-legal problems.

About Department of Law

The Department initially came into existence with scanty meagre resources in terms of the faculty and infrastructure; but with the passage of time, it made a significant progress in the academic domain as well as in other aspects. The Department started its Masters Programme (LL.M.) in the year 2014 and Ph.D in 2016. The courses run by the Department are in great demand in society, as a result of which one self-financing private law college viz Sarsuna Law College, Kolkata has been introduced under the affiliation of Bankura University. The Department of Law has progressed and grown into a prestigious Institute of legal study and research in the State. The Department has a rich library with modern facilities.

In the year 2016, the Choice Base Credit System (CBCS) Pattern was introduced and the present syllabus is based on the model curriculum framed by the University Grant Commission. This change in syllabus was much awaited and a demand was there to include new developments in the field of Law. To make this course more career oriented, the entire syllabus was modified thoroughly. At present, institutionalized instructions are offered in two specializations in the department which include Corporate Law and Constitutional Law & Administrative Law.

It has a well-equipped computer laboratory with Internet facility. All the members of the faculty have computers with Internet facility.

The Faculty of Law has been successfully pursuing higher standards of academic excellence. Faculties and Scholars of the Department also publish research papers on topics of contemporary relevance in various National and International Journals.

CONCEPT NOTE

It is not enough for a lawyer to spend their whole study in ascertaining differences between 'Law as it is' and 'Law what ought to be'. The syllabi of legal education should come out from the thinking of Oliver Wendell Holmes that a law student is supposed to follow what the courts are saying and nothing else or the concept that the laboratory of the lawyers is law library and their primary task is to study different doctrines and to establish or to find out the intrinsic relationship among them to get the favourable order and finally to take entry into the world of precedent and statutes. The pedagogy of legal education should be pragmatic, functional and realistic. It is not sufficient to enable the lawyers to drive the society towards some goals rather set out the new goals to support or challenge the transformation in the society. The legal scientists being a 'conscience keeper' or 'practical philosopher' as termed by Dworkin should orient themselves in such a way whereby, they will not only evolve the new principles to explain the long-perceived concept in a new way but even a new concept with a radical outlook and approach. Analytical mind of lawyer should be oriented towards empirical research, collaborative research and research in 'law in action' beside the doctrinal research.

A sound legal system should be multifaceted, multidisciplined and purposive oriented system to serve the needs of the society by balancing into the competing interests, aiming to strengthen the rule of law and to promote legal and judicial reforms to meet the challenges of governance in pace with the changing needs of the changing society. It has to explore innovative skills and to formulate proper mechanism to judge the diversified competing claims and to inform justice by redressing grievances thereby. It must address the requirements and challenges of the globalization and universalization of law, transnational law as well as municipal law and should equipped itself to meet the transition of the society from the industrial era to the era of information, from the discourse of traditional governance to e- governance with technical clarity and advancement, as the society is speedily tilting towards algorithmic society. Legal mechanism must be formulated in conformity with the economic and social realities with a philosophical outlook so that it can effectively influence the governmental policies to make it more justice centric, to undo the governmental wrongs and to achieve excellence and to become harbinger of social transformation. Law must have the contents to meet the demands of the market especially in context of changing international relations and the changing concept of sovereignty.

Selected papers, the selection of which will be made through peer review, will be published in book with ISBN Number and from a reputed publisher in India after completion of the Seminar.


Route Map
