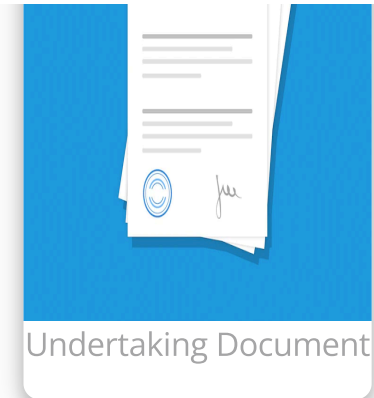
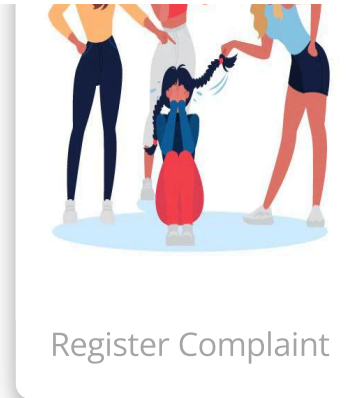
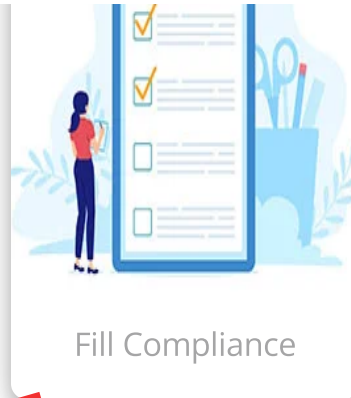
Ragging is a disturbing reality in the higher education system of our country.
