Admission to the Ph.D. programme shall be through Research Eligibility Test (RET) to be conducted by the University. The date and mode of RET shall be notified later.

Admission to the Ph.D. Programme shall be made using the following methods:

- i. University may admit students who qualify for fellowship/scholarship in UGC-NET/UGC-CSIR/NET/GATE/CEED and similar National level tests based on an interview/ viva-voce. And/or
- i. University may admit students through a Research Eligibility Test conducted through the Doctoral Committee of the respective Departments. The Research Eligibility Test syllabus shall consist of 50% of Research Methodology, and 50% shall be subject – specific.
- ii. Students who have secured 50% marks in the Entrance Test are eligible to be called for the interview /viva-voce.
- iii. A relaxation of 5% marks will be allowed in the Research Eligibility Test for the candidates belonging to SC/ST/differently – abled category, and other categories of candidates as per decision of the appropriate authority from time to time.
- iv. Provided that for the selection of candidates based on the Research Eligibility Test conducted by the University, a weightage of 70% of the marks obtained in the Research Eligibility Test and 30% of the performance in the interview/viva-voce shall be given.
- v. Students who have qualified for UGC-NET/UGC-CSIR/NET/GATE/CEED and similar National level tests without fellowship/scholarship have to appear for the Research Eligibility Test.
